

CERTIFICATION BY ELECTION SERVICES SOLUTIONS

Pursuant to a request of Utility Workers Union of America, Local 1-2, **Election Services Solutions** [ESS] designated Maralin Falik, President, to assign personnel to supervise a mail ballot election of Officers for the aforesaid union during the period of May 19, 2008 to 8:00 AM on June 7, 2008. The sealed ballots were retrieved from the Garden City Post Office at 8:00 AM on June 7, 2008 with observers from each slate present along with representatives from the Election Board. The results were tabulated at the La Quinta Hotel, 821 Stewart Avenue, Garden City New York commencing at approximately 9:00 AM.

Election Services Solutions hereby certifies that the election was conducted fairly and honestly.

Election Services Solutions further certifies that 9,946 (nine thousand nine hundred forty six) ballots were mailed to members based upon a listing provided by Local 1-2 and 4243 envelopes were returned as of 8:00 AM on June 7, 2008 (including one ballot received by overnight mail) to the secured post office box owned by Election Services Solutions at the Garden City Post Office. Of the 4243 envelopes returned, 9 (nine) envelopes were not included as follows: 7 (seven) were not Local 1-2 mail; 1 (one) was returned in a plain envelope and not the required business reply envelope and 1 (one) envelope had the name and bar code removed, for a total of 4243 (four thousand two hundred forty three) envelopes to be processed.

Election Services Solutions further certifies that (2) envelopes were challenged by an observer leaving 4241 (four thousand two hundred forty one) envelopes to be opened. Of the 4241 (four thousand two hundred forty one) envelopes containing ballots which were opened, 7 (seven) ballots were not included as follows: 1 (one) envelope did not contain a ballot; 1 (one) ballot was ripped in pieces; 1 (one) ballot contained name of voter; 1 (one) ballot contained initials of member; 2 (two) ballots were not official ballots; and 1 (one) ballot was blank, for a grand total of 4234 (four thousand two hundred thirty four) valid ballots as to the true and accurate results of the election.

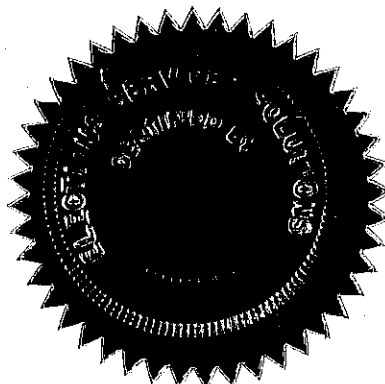
